## Victim Compensation

Experiencing or witnessing a crime can result in emotional or physical trauma and financial burdens. We are here to help.


## Victim Services

## The Justice Center provides many services to victims of crimes including:

- Information about criminal justice processes
- Accompanying service recipients (victims and witnesses) to interviews conducted by the Justice Center
- Accompanying service recipients (victims and witnesses) to court proceedings
- Referral to other victim assistance programs
- Providing information and status updates on an investigation
- Assistance with victim impact statements

How can the Justice Center's Individual and Family Support Services assist me?

Assistance with various aspects of completing the Compensation Claim Application can include:

- Explanation of the benefits available
- Help assembling requested documentation
- Assistance in making necessary contacts with the Office of Victim Services
- Submission of the claim application for processing

Who is eligible for compensation through the Office of Victim Services?

- An innocent victim of a crime
- Crime victims who were physically injured as a result of a crime
- Victims who are 60 and over who have a disability and were not physically injured
- Certain relatives and dependents
- Those individuals who paid for or incurred burial costs for an innocent victim
- Child victims and witnesses

What kind of expenses may I be eligible for?
The Office of Victim Services offers compensation related to personal injury, death and loss of essential personal property. The specific expenses that may be covered by the Office of Victim Services include:

- Medical and counseling expenses
- Loss or damage of essential personal property
- Transportation (necessary court appearances for prosecution)


## How do I qualify for compensation?

- Meet eligibility requirements
- Complete Office of Victim Services' application
- Have a current or future out of pocket loss as a result of a crime

Crime victims and witnesses should be treated with dignity, respect and understanding throughout their contact with the criminal justice system.

## Victim Rights

As the victim of a crime you have the right to:

- Request compensation
- Request assistance
- Receive notification of judicial proceedings
- Submit a victim impact statement
- Be protected from threats, physical injury or other types of intimidation
- Request a copy of the police report
- Request restitution
